O R D E R

1. Leave granted.
2. Although this matter is of the year 2026, yet as it involves issues relating to enforcement and execution of foreign awards, we have thought fit to give some priority and in such circumstances, notify the appeals for final hearing on 22.07.2026.
3. We are of the view, having regard to the fact that this litigation between the parties is now almost two decades old, they should make all possible endeavours to sit, talk and try to arrive at some equitable settlement.
4. In such circumstances, we appoint Hon'ble Mr. Justice Abhay S. Oka, former Judge of this Court to act as a Mediator between the parties.

5. The fees of the learned Mediator and other modalities shall be fixed in consultation with the parties.

6. Once the report of the learned Mediator comes on record, we shall proceed with the matter.
