8) In the meantime, by way of interim relief, it is directed that subject to cooperation of the petitioner in the investigation, no coercive steps shall be taken against him in connection with FIR No.10/2026 dated 09.01.2026 registered at Police Station Chhapar, Yamuna Nagar,

Haryana.

9) Counter affidavit may be filed within four weeks.
