In this petition filed under Article 139A(2) of the Constitution of India read with Section 25 of the Code of Civil Procedure, the petitioner has prayed for transfer of Civil Suit No. 2386 of 2010 titled 'Dr. Vibha Gupta and another versus QRG Enterprises Ltd. and others' pending in the High Court of Delhi to the Court of Civil Judge (Senior Division), Faridabad before whom Civil Suit No.S274 of 2010 titled 'Dr. Anoop Chopra and others versus Central Hospital & Research Center and others' is pending.
