This Transfer Petition has been filed by the

petitioner-wife seeking transfer of Matrimonial Case, Marriage Petition No. 521 of 2010 pending in the Family Court of Civil Judge (Senior Division), Thane at Thane, Mumbai to a Court of Additional District Judge (Matrimonial Cases) Jammu.

Looking to the convenience of the wife and without going into the allegations, we deem it appropriate to transfer the aforesaid case from Thane to Jammu.

The transferor Court is directed to send forthwith the entire record to the aforesaid cases to the transferee Court and on receipt of the same, the District Judge, Jammu, shall either keep them on his own board or assign them to a court of competent jurisdiction.

We further direct that the transferred case shall be heard with Matrimonial Case File No. 439/HMA and 447/HMA pending in the Court of Additional District Judge (Matrimonial Cases), Jammu.
