O R D E R

Delay condoned.

However, we are not inclined to entertain these special leave petitions insofar as they pertain to the purchasers under the thirty six (36) sale deeds executed between 07.11.2001 and 06.02.2002.

We are informed that the persons claiming under those sale deeds are arrayed as respondents herein but the learned counsel are unable to pinpoint with exactitude which respondents are to be

excluded on that count. They seek time to file amended memos of parties in both the matters, after deleting the respondents who are the purchasers in the aforesaid 36 sale deeds. The special leave petitions shall stand dismissed insofar as those respondents are concerned.

Issue notice to the remaining respondents, being those named in the amended memos of parties, returnable on 20.04.2026.

Notice shall be served by all modes, including *dasti*.

In the meanwhile, *status quo* obtaining as on date with regard to the properties, other than those covered by the aforesaid thirty six (36) sale deeds, shall be maintained.
