

by mutual consent under Section 13B of the Hindu Marriage Act, 1955 (for short, 'the Act').

In view of the settlement arrived at between the parties and the statement made by them before this Court, the application filed under Section 13B of the Act is disposed of in the following terms:

(i) Order dated 17.7.2012 by which the transfer petition was disposed of in terms of Settlement Agreement dated 4.7.2012 is recalled.

(ii) By exercising power of this Court under Article 142 of the Constitution read with Section 13B of the Act, we accept the prayer of the parties for dissolution of their marriage by mutual consent by waiving the statutory period specified in Section 13B. Accordingly, a decree of divorce by mutual consent is passed.

(iii) Petition No.1963 of 2012 pending in the Court of Additional District Judge, Alipore, West Bengal, Case No. 151 of 2011 filed by the petitioner under Section 125 Cr.P.C. for maintenance as also FIR filed under Section 498A read with Section 406 of the Indian Penal Code are withdrawn to this Court and are dismissed/quashed.

While disposing of the matter in the manner indicated above, we take cognizance of the fact that Shri Balraj Diwan, Advocate, who was appointed as Mediator, has handed over two demand drafts of rupees sixteen lacs to the petitioner.
