OFFICE REPORT FOR PRE FINAL HEARING

The matters above-mentioned were listed before Ld. Registrar Court on 10.11.2016 when the following order was passed:

“Ld. Counsel for the appellant in C.A. Nos.3848, 3850, 3852 and 3853/2014 has failed to file the affidavit of valuation despite opportunities. Viewed in that context, the matter shall be processed for listing before the Hon'ble Judge in Chambers for further future directions. Await orders. List thereafter.

In other matters, Ld. Counsel for the appellant shall file the statement of case within a period of four weeks. After expiry of four weeks. After expiry of four weeks, list the matter before the Hon'ble Court.”

It is submitted that Counsel for the appellant has on 28.11.2016 filed affidavit of valuation in Civil Appeal Nos.3848, 3850, 3852 and 3853 of 2014 also, as per which no amount of tax is involved in the instant appeals. Only a question of law is involved. As such there is no question of filing ad-valorem court fee.

It is further submitted that service of Notice of Lodgment of Petition of Appeal is complete in all the appeals above-mentioned as the sole respondent is represented through Mr. Naveen Kumar, Advocate in all the matters.

It is lastly submitted that Counsel for both the parties have not filed Statement of Case despite this Registry's notice dated 2.6.2016. Time to file Statement of Case has already expired as per amended rules.
