O R D E R

1. This is a petition for transfer of Matrimonial Suit No.87(11) of 2011 pending in the Court of Additional District Judge at 1st Court at Silliguri, within the State of West Bengal to the Court of Family Judge, Lucknow, within the State of Uttar Pradesh.

2. The petitioner has sought transfer of the aforesaid case mainly on the ground of financial difficulty and her inability to travel from Lucknow to Silliguri to attend the proceedings of the case filed by the respondent.
