O R D E R

1. This petition has been filed by the petitioner-wife seeking transfer of the Divorce Petition being Civil Misc. (NC) No.568 of 2025 titled "Udit Anil Mantri vs. Shivani Udit Mantri", filed by the respondent-husband, pending before the Court of Family Court No.03, Udaipur, Rajasthan to the competent Court of Principal Judge, Family Court at Aurangabad, Maharashtra.
2. The respondent-husband, although served with the notice issued by this Court yet has chosen not to remain present before this Court either in-person or through an advocate.
3. Sufficient cause having been made out by the petitioner-wife, warranting transfer of the case, as prayed for by her, the Transfer Petition deserves to be allowed. It is ordered accordingly.
4. Consequently, the Divorce Petition being Civil Misc. (NC) No.568 of 2025 titled "Udit Anil Mantri vs. Shivani Udit Mantri", pending before the Court of Family Court No.03, Udaipur, Rajasthan is ordered to be transferred to the

competent Court of Principal Judge, Family Court at Aurangabad, Maharashtra.

5. The transferor court shall forthwith transmit the record of the aforesaid case to the transferee court.
6. The transferee court shall make all possible endeavours first for an amicable settlement between the parties, failing which for early decision in the matter without unnecessary adjournments.
7. The respondent is permitted to attend the proceedings before the transferee court online, except on such date(s) when his personal presence is mandatorily required by the Court.
8. Pending application(s), if any, shall stand disposed of.
