Mr. Ardhendumauli Kumar Prasad, learned Senior Counsel
appearing for the petitioner/applicant submits that the

petitions were dismissed under unfortunate circumstances. He submits that the amount of Rs.23,80,000/- (Rupees Twenty Three Lakhs Eighty Thousand) was required to be paid by the petitioner to the respondent by 31.12.2025. However, due to compelling reasons, only Rs.12,00,000/- (Rupees Twelve Lakhs) was paid within time and for the balance sum, a demand draft for a sum of Rs.11,80,000/- (Rupees Eleven Lakhs Eighty Thousand) dated 28.01.2026 has been prepared, which the petitioner is carrying with him, but because of the order dated 20.01.2026, the petitioner cannot handover the same to the respondent. It was submitted that for the ends of justice, when the delayed payment is being made, the Court may grant indulgence to the petitioner/applicant.

2. Issue notice.

3. Learned Senior Counsel submits that the matter is short and can be disposed of upon the respondent accepting the draft and thus, it may be kept this week only and prayer is made to permit service to the other side through dasti mode.

4. Prayer is allowed.

6. In the meantime, no consequences shall follow with regard to the order dated 20.01.2026 passed in SLP(Crl.) Diary Nos. 3066/2025 and 3067/2025.
