within one week. The respondent shall bear the cost of travel and stay of the petitioner along

with one companion, which is quantified at Rs.3000/- per day of her appearance before the Court.

In the event, the petitioner herein files an application for examination of any witness on

commission, the same shall be considered on its merits. The cost incurred, therefore shall also be

borne by the respondent. With the above mentioned directions the transfer petition is disposed

of.
