O R D E R

1. In this petition filed under Article 137 of the Constitution read with Order XL of the Supreme Court Rules, the applicant Shri A. Raja has prayed for review of judgment dated 02.02.2012.

2. We have carefully perused the averments contained in the review petition and are convinced that there is no valid ground much less justification to entertain the prayer made by the applicant for review of judgment dated 02.02.2012.

3. The apprehension expressed by the applicant that the observations contained in various paragraphs of judgment dated 02.02.2012 will prejudicially affect his cause is not well-founded because in para 81(vii) of the judgment, it has been made clear that the observations contained in the judgment shall not prejudice any person including the applicant, who is facing prosecution in the cases registered by the C.B.I. or who may face prosecution on the basis of charge-sheet(s) which may be filed by the C.B.I. in future and the Special Judge, CBI shall decide the matter uninfluenced by this judgment. It has also been made clear that the judgment shall not prejudice any person in the action which may be taken by other investigating agencies under Income Tax Act, 1961, Prevention of Money Laundering Act, 2002 and other similar statutes.

4. With the above observation, the review petition is dismissed.

5. As a sequel to the above, the application filed by Shri A.Raja to file the review petition is dismissed.
