ORDER

1. Applications seeking permission to file special leave petition are granted.
2. Application seeking permission to appear and argue in person is allowed.
3. Delay condoned.
4. Leave granted.
5. The first appellate judgment and decree dated 07th October, 2025 of the High Court for the State of Telangana at Hyderabad is under challenge in these appeals.
6. We have heard Mr. Gopal Sankaranarayanan, learned senior counsel for the appellant(s) and Mr. B. V. Rama Narsimha Reddy, respondent appearing in person on caveat. He is also the proprietor of the respondent firms.
7. It appears from the judgment of the High Court that Section 114(g) of the Indian Evidence Act, 1872 was invoked and adverse inference drawn while reversing the judgment and decree of dismissal of the respondents' suits by the Trial Court and allowing the appeals of the respondents. Consideration of certain other provisions of the Evidence Act, having a bearing on the points arising for decision, appear to be missing.
8. Although brevity is the hallmark of precision and clarity, we find the impugned judgment to be too brief and not sufficiently reasoned to conform to Order XLI Rule 31 of the Code of Civil Procedure, 1908.
9. Be that as it may, having regard to the ultimate order we propose to pass on these appeals, it is not considered necessary to examine the rival contentions in any great depth. We set aside the impugned judgment and decree and direct a remand of the first appeals to be considered afresh by a Bench other than the Bench that considered the same earlier.

10. Observations made in this order are not to be considered as expression of any opinion by this Court on the merits. All contentions on merits are kept open to be urged by the parties before the Bench.

11. Having regard to the fact that institution of the respondents' suits dates back to 2005, we request the Chief Justice of the High Court to assign the appeals to an appropriate Bench for an early decision. It would be desirable if the first appeals are decided by the year end.

12. The appeals are, accordingly, allowed.

13. Pending application(s), if any, shall stand disposed of.
