O R D E R

1. Heard learned counsel for the parties.
2. The petitioners are apprehending arrest in connection with FIR No. 11191011240306 of 2024 dated 26.11.2024 registered with DCB Police Station, District-Ahmedabad City.
3. This Court *vide* orders dated 12.02.2026 and 16.03.2026 granted interim protection to the petitioners 'Babubhai Parshottamdas Patel' and 'Manishbhai Jayendrabhai Patel' respectively provided they join the investigation and cooperate with the Investigating Officer ('I.O.').
4. Pursuant to our aforesaid orders, the petitioners have joined the investigation and are

cooperating with the I.O..

5. Learned counsel for the State of Gujarat accepts that the petitioners have joined the investigation.

6. In view of the aforesaid facts and circumstances, we make the interim orders of this Court dated 12.02.2026 and 16.03.2026 absolute provided they continue to participate in the investigation.

7. In the event of arrest of the petitioners pursuant to the aforesaid FIR, we direct that the petitioners be released on bail subject to the terms and conditions that may be imposed by the Trial Court.

8. The special leave petitions stand disposed of in the above terms.
