2. Learned counsel for the petitioner has filed a letter dated 19.01.2026 regarding correction in the name of the petitioner which reads as "Metro Development vs. Gajanan Goma Veer and Ors." whereas, in the order dated 16.05.2025 passed by this Court in Civil Appeal No.7022 of 2025, it has been shown as "M/s Metro Development Thr. its Authorise Partners and Anr. vs. Gajanan Goma Veer and Ors.".
