3. After having heard learned counsel appearing for the petitioner(s) and respondent(s) at length, in modification of this Court's order dated 08.09.2025 passed in M.A.No. 1409 of 2025 in Civil Appeal No. 9048 of 2012, we pass the following directions :-

"permission for opening of portal of Pharmacy Council of India for filing the SIF qua list of existing colleges is extended for three weeks from today for the academic session 2026-2027."
(emphasis supplied)

4. With these observations and directions, the misc. application(s) and writ petitions are disposed of.
