O R D E R

Learned counsel for the respondent-Cotton Corporation of India  
submits that arbitral awards have already been published by the  
Arbitrators concerned and that the petitioners in these petitions have  
already questioned the said awards in proceedings under Section 34 of  
the Arbitration and Conciliation Act, 1966 before the competent court  
thereby rendering these transfer petitions infructuous. He prays for  
dismissal of these petitions on that ground.

Learned counsel for the petitioner submits that while the awards  
have already been published by the Arbitrators, the petitioners should  
have the liberty to raise all such contentions as are otherwise open  
to them before the competent court in proceedings under Section 34 of  
the Arbitration and Conciliation Act, 1966.

In that view of the matter therefore we dismiss these transfer  
petitions as infructuous with liberty to the petitioners to seek  
appropriate redress in proceedings under Section 34 already initiated  
by them. We make it clear that the petitioners shall be free to raise  
all such questions as are otherwise open to them in the said  
proceedings including questions relating to the existence and

validity of the contract between the parties. No costs.
