O R D E R

SLP(C) No. 27650/2025

Sole respondent has filed counter affidavit alongwith an application seeking permission to file additional documents.

Registry to process the matter for listing before the Hon'ble Court as per rules alongwith pending applications.

SLP(C) No. 27651/2025

Service was complete on respondent nos. 1 to 3 and 5 in October, 2025 but none has entered appearance.

Ld. counsel for the petitioner is granted one weeks' time to take fresh steps and file fresh particulars with regard to service on respondent no.4.

List again on 15.07.2026.

SLP(C) No. 28184-28185/2025

Service was complete on both the respondents in October, 2025 but no counter affidavit has been filed yet. Hence, one weeks time as last opportunity is granted to file the same. If filed let the same be taken on record, else further opportunity to file the same would stand declined.
