UPON hearing the counsel the Court made the following  
O R D E R

Pursuant to our order dated 26.02.2026, Ms.Ivneet Kaur Walia, officiating Registrar of Rajiv Gandhi National University of Law (RGNUL) is present before this Court.

2. Learned counsel appearing for her submitted that an affidavit has been filed by her tendering an unconditional and unequivocal apology for filing the recalling application before this Court. She has also stated that the said application was filed pursuant to the decision taken by the Vice Chancellor and she has only acted on the said decision.

3. A compliance affidavit has also been filed by Dr.Abhinandan Bassi, presently in-charge Admission Committee at the RGNUL stating that the Writ Petitioner herein has been granted admission and she has also been allotted hostel facility and she is attending classes.

4. In the circumstances, learned counsel for respondent No.5-RGNUL submitted that permission may be granted to

withdraw the Miscellaneous Application and the affidavits filed may be taken on record and the matter may be given a quietus.

5. Learned counsel for the petitioner submitted that since the petitioner has been granted admission and hostel facility and is attending classes, appropriate orders may be made.

6. We take note of the affidavits filed and also an unconditional apology which has been tendered by the officiating Registrar of the RGNUL as well as the compliance affidavit filed on behalf of the respondent No.5 and accordingly, we dismiss this Miscellaneous Application as not pressed.
