UPON hearing the counsel the Court made the following
O R D E R

1. Mr. Abhinav Sharma, learned counsel for the petitioners draws attention to page 235 (pdf 249) of the paper books. Learned counsel for the petitioners submits that Sh.Gyanesh Pathak-respondent no.3 was not authorized to enter into any settlement and withdraw the case without the permission of the Neotown Social Welfare Society-respondent no.2(for short,

'Society'). When it was put to learned counsel for the petitioners that out of 71 members who are concerned with the case only 4 have complained by virtue of the present petition, learned counsel for the petitioners seeks time to take instructions to find out whether the other 67 members have received the payments along with 6% p.a. interest.

2. Let an affidavit be filed in this regard.
3. We permit the petitioners herein to write to the Society to seek an information as to how many members have received the money. The Society shall inform by a written communication about the correct state of affairs.
4. Let the same be placed on record.
5. List on 15th May, 2026.
