After hearing learned counsel for both the parties we dispose of

this appeal in modification of the High Court's order in the following

terms :

The property involved in this dispute are Survey Nos. 224/80,
224/50 and 224/84.

In Survey No. 224/80 the land in dispute consists of 9 cents, in
Survey No.224/50 the land in dispute consists of 5 cents and in Survey
No.224/84 the land in dispute consists of 8 cents.

So far with regard to Survey No.224/84 regarding the land of 8

cents both the parties submit that there is no dispute meaning thereby the appellant herein shall take 3 cents and the respondent herein shall take 5 cents.

With regard to the land in Survey No.224/80 the land consists of 9 cents the appellant herein shall take 5 & ½ cents and the balance of 3 and ½ cents shall go to the respondent herein.

With regard to the land in Survey No.224/50, the land consists of 5 cents, the appellant herein shall take 1 & ½ cent and the respondent herein shall take 3 & ½ cents.

The land of the appellant shall, however, be contiguous.

The appeal is disposed of in the above terms. No costs.
