Further, no one has entered appearance on behalf of Respondent Nos. 8, 11 & 14 so far. Fresh notice could not be issued to respondent Nos. 2 to 7, 9, 10, 12 and 13 as counsel for the petitioner has not filed spare copies of Special Leave Petition so far.

SLP(CRL.) NO. 2512/2013
