OFFICE REPORT

The matters above mentioned were listed before the Ld. Registrar Court on 25.04.2014 when the following Order was passed:-

SLP(C) NO.17684/2013

Respondent No.1 has failed to file counter affidavit despite final chance granted on the last date.

Respondent nos. 2 to 4 have already filed counter affidavit on record.

On behalf of respondent Nos. 5 to 9 on the last date the ld. Counsel, Mr. Pravir Choudhary had accepted notice and undertaken to file vakalatnama and counter affidavit but till date no steps seems to have been taken. However, further necessary orders would be passed as and when other connected matters would become ready.

Service on remaining respondent NO.10 is complete but none appeared nor any steps taken on his behalf.

SLP(C) NO.17685/2013

Six weeks time is granted as final chance to respondent Nos. 1 and 5 for filing counter affidavit.

Respondent Nos. 2 and 4 have already filed counter affidavit on record.

Respondent Nos. 6 and 7 are common in the other connected SLP(C) No.12624/2013 and have been duly served in that matter. Therefore, they are deemed to be duly and properly served in the present matter also. There is no appearance on their behalf.

SLP(C) NO.12623/2013

Counter affidavit on behalf of respondent No.1 has already come on record.

Respondent Nos. 2 to 4 have already filed counter affidavit on record.

Respondent Nos. 7,8 and 10 are reported to be duly served but none appeared nor any steps taken on their behalf.

On filing of process fee, spare copies and complete address of the District Court within three weeks notices be issued forthwith to respondent nos. 5,6 and 9. In addition postal service allowed.

SLP(C) NO.12624/2013

Counter affidavit on behalf of respondent Nos. 1 to 5 has come on record.

Respondent Nos. 6 and 7 are common in the other connected SLP(C) No.17685/2013 and have been duly served in that matter. Therefore, they are deemed to be duly and properly served in the present matter also. There is no appearance on their behalf.

However, further necessary orders would be passed as and when other connected matters would become ready.

It is submitted that Mr. Pravir Choudhary, Advocate has not filed vakalatnama/appearance and counter affidavit on behalf of respondent Nos. 5 to 9 in SLP(C) No. 17684/2013 so far. Counsel appearing for respondent Nos. 1 and 5 have not filed counter affidavit so far in SLP(C) No. 17685/2013.

It is further submitted that counsel for the petitioner has neither furnished the address of concerned District Court nor filed process fee and spare copies for service of notice upon respondent Nos. 3, 6 and 9 in SLP(C) No. 12623/2013.

Service is not complete on respondent Nos. 5 to 9 in SLP(C) No. 17684/2013 and respondent Nos. 5, 6 and 9 in SLP(C) No. 12623/2013.
