Under the Orissa Education(Establishment, Recognition and Management of Junior Colleges/Higher Secondary Schools) Rules, 1991 certain rules were framed by the Orissa Government for a report to be made of the change of the constitution of the Governing Body of the educational institutions which have been recognised or affiliated as a junior college.

When the matter was brought up before the High Court, it was noticed that the action taken by the Director was in the interest of the institution and further, more than one year had elapsed since the reconstitution of the Governing Body even during the pendency of the proceedings before the High Court and the matter had become infructuous.
