In this appeal the only grievance raised by the appellant is
that the High Court has wrongly recorded in its order dated

22.12.2005 Rs.21 lakhs per acre, instead of reading Rs.21 lakhs per acre it should read as Rs.21 lakhs for the whole land. From the order of the Religious Endowment Commissioner it clearly appears that the Commissioner of Endowment has fixed the upset price for the auction of the land at Rs.6 lakhs per acre. This would clearly show that the amount of Rs. 21 lakhs is shown for whole land and not for per acre. We accordingly hold that the upset auction price is at Rs. 6 lakhs per acre and for the whole land it is fixed at Rs.21 lakhs.

With this modification the appeal is disposed of.
