O R D E R

1. By this petition, petitioner-wife seeks transfer of Family Suit No.286 of 2025, pending before Family Court at Surat, Gujarat to Family Court, Aurangabad, Bihar.

2. We have heard learned counsel for the petitioner and perused the record.

3. As per the office report dated 21.04.2026, service of notice has been completed on the sole respondent-husband, but there is no appearance on his behalf.

4. Upon consideration of the submissions and perusal of materials available on record, we are of the view that this Transfer Petition deserves to be allowed. Accordingly, Family Suit No.286 of 2025, pending before Family Court at Surat, Gujarat is transferred to Family Court, Aurangabad, Bihar. The transferor Court shall transmit the entire record of the case forthwith to the transferee Court.

5. For convenience of the parties, we deem it appropriate to observe that it will be open to the parties to appear through video conferencing platform except on occasions where their physical presence is necessary.

6. The Transfer Petition is allowed in the above terms.
