The Interlocutory Application Nos. 12 & 13 in C.A. No. 11111 of 2014 and Interlocutory Application No. 14 in C.A. No. 11117 of 2015 in the matter above-mentioned were listed before the Hon'ble Court on 27th July, 2015, when the Court was pleased to pass the following order:-
