O R D E R

1. Pursuant to the order dated 01.04.2026, learned State counsel fairly states that the applicant's child is suffering from a disease mentioned in paragraph 2 of the order and is critically ill. That being so, the condition imposed on the applicant vide order dated 28.01.2026 prohibiting his entry in the State of Chhattisgarh is suspended, and that condition is ordered to be kept in abeyance. Accordingly, the applicant is permitted to stay with the child for the purpose of medical treatment. However, the State shall be at liberty to apply for reinforcement of that condition if there is any change in the circumstances.
