O R D E R

1. This petition has been filed by the petitioner-wife seeking transfer of Case bearing P.A.No.1494/2025 titled as "*Anurag Soni vs. Shilpi Soni*", pending before the Family Court, Pune, Maharashtra to the Family Court, Bhopal, Madhya Pradesh.
2. None appears on behalf of the respondent in spite of service of notice.
3. Having heard learned counsel appearing for the petitioner, we are inclined to transfer the case sought for. We, accordingly, allow the transfer petition and direct that Case bearing P.A.No.1494/2025 titled as "*Anurag Soni vs. Shilpi Soni*", pending before the Family Court, Pune, Maharashtra be transferred to the Family Court, Bhopal, Madhya Pradesh.

6. The transferee Court shall make all possible endeavours first for an amicable settlement between the parties, failing which for early decision in the matter without unnecessary adjournments.
