Leave granted.

The appellant seeks bail in connection with FIR No.11204045230661, dated 01.12.2023, registered at Police Station-Nadiad Rural, District-Kheda for the offences punishable under Sections 304, 308, 328, 465, 467, 468, 471, 274, 275, 276, 201 read with 34 and 120-B of the Indian Penal Code, 1860 and Sections 65(A), 67-1(A), 67-A(1-a) and 81 of the Gujarat Prohibition Act, 1949.

We have heard the learned counsel appearing for the parties.

It is not in dispute that the manufacturer of the medicine has been granted bail. The charge

against the appellant is that he being a distributor was responsible for the offence alleged. Further, he has undergone incarceration for more than two years.

Considering the aforesaid factual scenario, we are inclined to grant bail to the appellant.

Accordingly, the impugned order is set aside and the appellant is granted bail on terms and conditions to the satisfaction of the concerned Trial Court.

The appeal stands allowed accordingly.
