UPON hearing the counsel the Court made the following
O R D E R

1. The application for permission to file the Special Leave Petition is allowed.
2. The application for exemption from filing the attested affidavit is also allowed.
3. Having heard learned counsel appearing on behalf of the petitioner and on carefully perusing the material placed on record, we see no reason to interfere with the impugned order passed by the High Court allowing the bail application filed by respondent Nos.2 and 3.

4. The Special Leave Petition is, accordingly, dismissed.
5. In case respondent Nos.2 and 3 do not co-operate with the investigation or try to influence the witnesses, the petitioner would be at liberty to move an application for cancellation of bail granted to them by the High Court.
6. Consequent upon dismissal of the Special Leave Petition, pending interlocutory applications also stand disposed of.
