The present Transfer Petition has been filed under Section 25 of the Code of Civil Procedure, 1908 seeking transfer of HMOP No. 87/2022 titled as "*Ajay Nagpuria vs. Jaini Kumawat*" pending before the Court of Principal Judge, Family Court at Coimbatore, Tamil Nadu to the Court of Principal Judge, Family Court at Beawar, Dist. Ajmer, Rajasthan.

Having heard learned counsel appearing for the parties and considering the averments in the Petition, a case is made out to transfer HMOP No.87/2022 from Coimbatore, Tamil Nadu to Dist. Ajmer, Rajasthan.
