Heard learned counsel for the petitioner and Mr. K.M. Nataraj, learned Additional Solicitor General appearing for the respondent-National Investigation Agency.

The petitioner seeks interim bail on the ground that his mother is ailing and requires his assistance for medical treatment of various health issues. Considering the facts and circumstances as available on record, we direct that the petitioner be released on short term bail for a period up to 12th July, 2026. The petitioner shall be released from custody on such terms and conditions as the Trial

Court may fix. He shall surrender back on 13th July, 2026.

The Trial Court, while accepting the bail bonds, shall impose appropriate conditions as may be pressed by the prosecuting agency.

In the event the petitioner does not surrender on 13.07.2026, it would be open for the Trial Court to take such steps as may be necessary to ensure his custody.

The special leave petition is disposed of.

Pending applications shall stand disposed of.
