1. Leave granted.

No. 457 of 2012 in First Appeal Stamp No. 25040 of 2011, C.A. No. 458 of 2012 in First Appeal Stamp No. 25191 of 2011 as well as in C.A. No. 1932 of 2012 in C.A. No. 459 of 2012 in First Appeal Stamp No. 165 of 2012, C.A. No. 1931 of 2012 in C.A. no. 457 of 2012 in First Appeal No. 163 of 2012, C.A. No. 457 of 2012 in First Appeal No. 163 of 2012, C.A. No. 1930 of 2012 in C.A. No. 458 of 2012 in First Appeal No. 164 of 2012 respectively dated 20.01.2012 and 22.02.2012. By the impugned judgment and order, the High Court has rejected the reasonable prayer made by the appellants herein.

3. Having heard the learned counsel for the parties to the lis, we are of the opinion that the prayer made by the appellants requires to be granted. Accordingly, we pass the following order-

"We direct that the 50% of the enhanced compensation granted to the appellants shall be released without security whereas balance of 50% shall be released to them on furnishing security to the satisfaction of the Collector".

4. The appeals are disposed of accordingly.
