Aggrieved by the recommendations made by the Karnataka High Court for elevation to the High Court which did not include the name of the petitioner/applicant, a writ petition under Article 32 was filed by the petitioner/applicant which was dismissed by this Court on 04.05.2020. made during the course of hearing and, therefore, were not dealt with in the order dated 04.05.2020.

In the facts of this case, we grant liberty to the petitioner/applicant to approach the High Court for the relief of reconsideration of functional promotion as District Judge (Super Time Scale).

The miscellaneous application is, accordingly disposed of.
