**UPON hearing the counsel the Court made the following
O R D E R**

We have heard Mr.K.V. Vishwanathan, learned senior counsel appearing on behalf of the petitioners as well as Mr. R. Basant, learned senior counsel appearing on behalf of the respondent-State of West Bengal along with Mr. Suhaan Mukherji, learned standing counsel for the State of West Bengal.

So far as the petitioners are concerned in SLP(Cr1.) No. 1033 of 2020 by the order dated 10.02.2020, this Court has granted interim protection.

Learned senior counsel appearing for the petitioner has submitted that on the very same day i.e. 10.02.2020, F.I.R. No. 32/2020 was registered against the petitioners. It is also submitted that F.I.R. No. 48/2020 dated 27.02.2020 was also registered against the petitioners.

Having regard to above submissions, the petitioners are granted interim protection from arrest in P.S. Case No. 05 of 2020 dated 02.01.2020, PS Case No. 03 of 2020 dated 02.01.2020, FIR No. 15 of 2020 dated 22.01.2020, FIR No. 32 of 2020 dated 10.02.2020 and PS Case No. 48 of 2020 dated 27.02.2020 subject to the condition that they shall co-operate with the investigation until further orders from this Court. If any of the petitioners are in possession of the passport, the same shall be surrendered before the concerned police station.

Insofar as Prayer (a) and (b) are concerned, issue notice to the respondents.
