The petitioner- wife has filed this petition seeking transfer of the
divorce petition filed by the husband pending on the file of Civil Judge,
Etawa h (U.P.) to Bhopal (M.P.).

2. Petitioner claims to be without support and only semi literate.
She also apprehends threats or violence at Etawa h. She also finds it

difficult to travel alone to Etawah. On the facts and circumstances this is a fit case for transfer.

3. It is evident from the cause- title that the petitioner- wife is a permanent resident of a village in Bhind district of M.P. The divorce petition is filed at Etawah which is nearer to Bhind when compared to Bhopal. Therefore, both sides submitted that instead of the case being transferred to Bhopal, it may be transferred to Bhind (M.P.)

4. We, accordingly, allow this transfer Petition. HMA No.388 of 2007 titled Neeraj Dikshit Vs. Smt. Akhilesh Dikshit pending before the Court of civil Judge, Etawah, U.P. is ordered to be transferred to District Judge, Bhind (M.P.) who may either try the same himself or assign it to a Court of competent jurisdiction at Bhind.
