O R D E R

1. Heard learned counsel for the petitioner.
2. This transfer petition has been filed by the petitioner-wife. The respondent-husband has filed a petition under Section 13(1)(ia) and 13(1)(ib) of the Hindu Marriage Act, 1955 for decree of divorce before the Family Court, Gurugram, Haryana. The petitioner-wife prays that the matter be transferred to the Family Court, Pune (Maharashtra).
3. Considering the facts and circumstances of the case, we are of the view that the matter is liable to be transferred.
4. Accordingly, this Transfer Petition is allowed and case bearing H.M.A No. 26 of 2024 titled as "Sushant Hastu vs Sunakshi Wangu" pending before the Principal Judge, Family Court, District Gurugram (Haryana) is transferred to the District Family Court, Pune (Maharashtra).

5. After the matter is transferred to the District Family Court, Pune (Maharashtra), the concerned Court will give fresh notice to all the parties by fixing a date and the aforesaid matter shall proceed at the District Family Court, Pune (Maharashtra) from the stage it was left at the Family Court, District Gurugram (Haryana).

6. The parties may be allowed to appear virtually unless their physical presence is required.

7. The records of the case be transferred to the transferee Court forthwith.

8. All pending applications stand disposed of.
