Varied issues regarding gross-irregularities in the matter of distribution of essential supplies and services during COVID-19 pandemic have been raised and considered in the lead matter as well as connected petitions. Some matters also pertain to the grant of compensation and/or refund of the expenditure incurred on treatment from a private hospital, over and above the limit fixed by this Court.

7. In our considered opinion, these independent issues cannot be adjudicated in the instant proceedings. The larger issues, namely, the challenges which the nation suddenly faced during the COVID-19 Pandemic were effectively dealt with by this Court at the relevant time through various orders passed from time to time. The situation being no longer in existence, these issues have become infructuous. The instant proceedings are, accordingly, disposed of, with liberty to each and every individual to raise their respective claim before appropriate forum. It goes without saying that if the parties approach the relevant hospital, they shall determine the claim, if any, in accordance with law.

8. We make it clear that we have not expressed any opinion on merits of the individual claim.
