O R D E R

1. The petitioner has been denied bail by the High court of Judicature at Patna in connection with Cyber Police Station Case No. 69 of 2025 registered for the offence punishable under Sections 303(2), 318(2), 318(4), 319(2), 336(2), 336(3), 338, and 340(2), respectively of the Bharatiya Nyaya Sanhita, 2023, (for short, "the BNS, 2023") and Sections 66 and 66(D) of the Information and Technology Act, 2000, respectively (for short, "I.T. Act).

2. We heard the learned counsel appearing for the parties.

3. We take notice of the fact that the petitioner a 21 year old boy is in jail past 11 months. The investigation is completed and charge sheet has been filed.

4. The filing of the charge sheet has culminated in Gr.Case/3399/2025 pending in the Court of the ACJM VI, Nalanda.

5. In the overall view of the matter, we are convinced that the petitioner has been able to make out a case for release on bail. In the result, it is ordered that the petitioner be released on bail forthwith, if not required in any other case, subject to terms and conditions that the Trial Court may deem fit to impose.

6. With the aforesaid this petition stands disposed

of.
