O R D E R

1. Leave granted.
2. Heard learned counsel for the parties.
3. This appeal arises from an order dated 11.08.2025 passed by the High Court of Bombay, Bench at Aurangabad rejecting the regular bail prayer of the appellant(s) in connection with Crime No. 847/2024, registered at P.S. Shrirampur, Taluka Shrirampur, District Ahmednagar.
4. At the outset, learned counsel for the appellant(s) submits that there are 11

accused who have been implicated by leveling general allegations against them of assaulting the deceased with a rope and a belt. It is submitted that 4 co-accused have already been granted bail and one of them has been granted bail by this Court. In such circumstances, the case of the appellant(s) which stand on a similar footing should also be accorded same treatment.

5. The learned Counsel for the State-respondent has opposed the prayer for bail but could not dispute that co-accused have been admitted to bail under orders of this Court.

6. In such circumstances, the appeal is allowed. The order passed by the High Court rejecting the regular bail prayer of the appellant(s) is set aside.

7. The appellant(s) shall be released on bail on such terms and conditions as the trial

court may deem fit to impose in the facts and circumstances of the case.

8. Pending application(s), if any, shall stand disposed of.
