O R D E R

1. This transfer petition has been filed by the petitioner-wife seeking transfer of Divorce Petition bearing Matrimonial Case No.1324 of 2025 titled "*Vikas Jain @ Bhole vs. Chanchal Jain alias Pooja*" from the Principal Judge, Family Court, Firozabad, Uttar Pradesh to the competent Family Court, Ahmedabad, Gujarat.

2. As per office report, service of show-cause notice is deemed complete as the respondent has refused to accept notice. None is present on behalf of the respondent.

3. Heard learned counsel for the petitioner and perused the material placed on record.

4. We have considered the facts of the case and

grounds on which transfer has been sought. On such consideration, we are satisfied with the grounds urged by the petitioner and accept the same. Therefore, *Matrimonial Case No.1324 of 2025* titled "*Vikas Jain @ Bhole vs. Chanchal Jain alias Pooja*" pending before the Principal Judge, Family Court, Firozabad, Uttar Pradesh is ordered to be transferred to the District Judge, Ahmedabad, Gujarat, who may hear the case himself or assign it to a Court of competent jurisdiction.

5. Records of the case should immediately be transferred to the transferee court.

6. The parties may explore the possibility of settlement through Mediation. The transferee court would obtain the desire and wishes of the parties and proceed accordingly in this regard.

7. The parties are at liberty initially to appear through virtual mode. If such request is made, the concerned court may favourably consider the same and thereafter, if need be, the parties

can be asked to appear through physical mode.

8. The Transfer Petition is allowed accordingly.

9. Pending application(s), if any, shall stand disposed of.
