**OFFICE REPORT**

The matters above mentioned were listed before the Hon'ble Court on 22<sup>nd</sup> August, 2014 when the Court was pleased to pass the following order:-

**"Learned counsel for the petitioners undertakes to furnish a copy of the rejoinder affidavit to the learned counsel for the respondent during the course of the day. List after four weeks."**

It is submitted that pursuant to the above quoted order, Counsel for the Petitioners has not filed proof of service of the copy of rejoinder affidavit to the Counsel for the respondent so far.

Thereafter, the matters above mentioned were listed before the Hon'ble Court on 26<sup>th</sup> September, 2014, when the Court was pleased to pass the following order:-

**"Pleadings are complete. List for hearing on a non-miscellaneous day after eight weeks."**

**Service position of each matter is as under:-**

**Special Leave Petition(C)No. 11453 OF 2013**

It is submitted that there is a sole respondent and is represented through Mr. L.K. Pandey, Advocate. He has also stated before the Hon'ble Court on 18<sup>th</sup> July, 2014 that it is not necessary to file any Counter Affidavit.

Service of show cause notice is complete.

**Special Leave Petition(C)Nos. 18413-18421 OF 2013**

It is submitted that there is sole respondent in all Special Leave Petitions. Mr. Raghavendran S. Srivastava, Advocate has filed Vakalatnama and Memo of Appearance and Counter Affidavit in respect of the sole respondent in SLP(C)Nos. 18413-18416 and 18421 of 2013. It is further submitted that Mr. S.N. Terdal, Advocate for the Petitioners has on 2<sup>nd</sup> April, 2014 filed Affidavit of dasti service in respect of the sole respondent in both the Special Leave Petitions but no one has entered appearance on his behalf.

Service of show cause notice is complete.

**Special Leave Petition(C)No. 37862 OF 2013**
