OFFICE REPORT

The matters above mentioned were listed before the Hon'ble Court on 10th March, 2014 when the Hon'ble Court was pleased to pass the following order:-

"A perusal of the office report dated 7.3.2014 reveals that service of notice is not complete in S.L.P.(C) No. 18413/2013, S.L.P.(C) No.18415/2013, S.L.P.(C) No.18421 of 2013 and S.L.P.(C) Nos.33513-33514 of 2013. In the last matter, referred to above, service could not be effected because learned counsel for the petitioners failed to file even the process fee. This is clearly unacceptable.

In the interest of justice, however, one last adjournment is granted to the petitioners to take steps for completion of service of notice in the aforesaid special leave petitions, subject to payment of cost of Rs.10,000/- which shall be deposited with the Supreme Court Advocate-on-record Welfare Trust within two weeks from today.

Liberty is, however, granted to the petitioners to serve the respondents in the aforesaid special leave petitions through dasti process in addition."

SLP(C) No. 11453 of 2013

It is submitted that there is a sole respondent and is represented through Mr. L. K. Pandey, Advocate but he has not filed counter Affidavit so far.

Service of show cause notice is complete.

SLP(C) Nos. 18413-18421 of 2013

Show cause notice was issued to the Sole respondents in all the Special Leave Petitions. Mr. Raghavendra S. Srivastava, Advocate has filed vakalatnama/appearance in respect of Sole Respondents in Special Leave Petition (C) Nos. 18413-18416 and 18421 of 2013 but he has not filed counter affidavit on their behalf. A.D. cards duly signed have been received in respect of sole respondent in Special Leave Petition (C) Nos. 18417 to 18420 of 2013 but no one has entered appearance on their behalf.

Service of show cause notice is complete in all the Special Leave Petitions.

SLP(C) Nos. 33513-33514 of 2013

Pursuant to order quoted above Mr. S. N. Terdal, Advocate has on 24th March, 2014 deposited Rs.10,000/- with the Supreme Court Advocate on Record Welfare Trust. Thereafter, show cause notice issued to Sole Respondent in both the Special Leave Petitions have been issued on 15.04.2014 through registered A.D. and dasti as well. Neither A.D. card nor unserved cover has been received back from the Respondents.

It is submitted that Mr. S. N. Terdal, Advocate has on 2nd April, 2014 filed affidavit of service but he has not filed proof of dasti service on the Sole Respondents on both the Special Leave Petitions.

SLP(C) No. 37862 of 2013

Pursuant to order quoted above show cause notice was issued to sole respondent and A.D. card duly signed has been received back from the sole respondent but no one has entered appearance on his behalf.
