O R D E R

1. Petitioner challenges the judgment and order dated 02.02.2026 in Bail Application No.260/2026 passed by the High Court of Kerala at Ernakulam, titled "*Jibin S vs. Station House Officer & Anr.*".
2. We have heard learned counsel for the petitioner.
3. Issue notice, returnable on 02.04.2026.
4. Mr. Harshad V. Hameed, learned counsel, accepts notice

on behalf of the respondents. Hence, the formal service of notice on the respondents are waived.

5. Learned counsel for the petitioner to serve an advance copy of the present petition to the learned counsel for the respondents within a period of one (01) week.

7. We make it clear that no further opportunity will be granted for this purpose.

8. In the event of arrest in connection with Crime No.30 of 2024 of Thaliparamba Police Station, Kannur Rural District, Kerala, the petitioner shall be released on bail on the appropriate terms and conditions as may be fixed by the Investigating Officer/Arresting Officer.

9. The petitioner shall make himself available before the Investigating Officer on 10.03.2026 at 10:00 a.m. and on all such dates as he may be required.

10. Needless to add, till the investigation is not complete in all respects, the petitioner would fully cooperate, and if the challan/charge sheet is filed, he would maintain good conduct and not attempt to influence any of the witnesses in any manner till the completion of the trial.
