O R D E R

1. The petitioner-wife has filed the petition under Section 25 of the Code of Civil Procedure, 1908 before this Court seeking transfer of Divorce Petition No. 136 of 2023 titled as "*Ajay Kumar Sharma vs. Shweta Sharma*" pending before the Family Court, Rudrapur, Udham Singh Nagar, Uttarakhand to the Court of Principal Judge, Family Court, Sambhal, District Moradabad, Uttar Pradesh.
