O R D E R

This is wife's petition seeking transfer of matrimonial petition being H.M.A. No. 9/2012 titled "Santosh Vs. Chanchal @ Mona" from the Court of the Third Additional District Judge, Mandsaur, Madhya Pradesh to the District Judge, Chittorgarh, Rajasthan.

2. Notice of the transfer petition has been issued to the respondent, but despite service the respondent has not chosen to appear.

3. Having regard to the fact that the petitioner-wife resides at Chittorgarh, Rajasthan, we are satisfied that if the proceedings in the above matrimonial petition are allowed to be continued at Mandsaur, Madhya Pradesh, greater hardship shall be caused to her.

4. We, accordingly, allow the Transfer Petition and transfer matrimonial petition being H.M.A. No. 9/2012 titled "Santosh Vs. Chanchal @ Mona" from the Court of the Third Additional District Judge, Mandsaur, Madhya Pradesh to the District Judge, Chittorgarh, Rajasthan. It will be open to the District Judge, Chittorgarh, Rajasthan to transfer the above matrimonial case for disposal to any other competent court within his jurisdiction. The transferor court shall transmit the entire record and proceedings pertaining to the above transferred matrimonial petition to the transferee court without any delay. No costs.
