O R D E R

1 Heard Mr. Choudhari, in support of this application. Mr. Desai appears for the State of Maharashtra.

2 This application seeks disposal of the civil appeal in terms of the judgment rendered by this Court in SLP(C)No.3314 of 2010. In that judgment rendered on 7.12.2011, this Court has taken a view that although caste claim of that petitioner was invalidated inasmuch as that petitioner had completed his education in the meanwhile, his educational qualifications should not be disturbed. This Court also held that beyond that the petitioner will not be entitled to any further benefit on the basis of caste claim.

3 The present appellant has passed the examination of Bachelor of Physiotherapy on the basis of a reserved seat in November-December, 2010. Mr. Choudhary appearing for the applicant, states that the applicant will not be claiming any benefit as belonging to the particular reserved community. However, her result may be declared in view of the fact that similar order has been passed in the earlier matter.

4 We accept the submissions and allow this interlocutory application. Resultantly, Civil Appeal stands allowed.

5 The result of the appellant's examination be declared by the university. She will be issued the necessary degree certificate. We, however, make it clear that hereafter the appellant will not be entitled to any benefit, as belonging to the particular reserved category.
