O R D E R

1. The petitioner has filed this Transfer Petition seeking the following reliefs:

“Pass an order directing the transfer of the petition for Restitution of Conjugal Rights filed by the respondent against the petitioner being Abhishek Ghai v. Jyoti Ghai, HMA/166/2021 pending before the Civil Judge (Senior Division) at Chandigarh to the Court of Principal Senior Civil Judge, Bangalore Rural District.”

2. We have heard learned counsel for the petitioner and learned counsel for the respondent.

3. Learned counsel for the petitioner submitted that there are three other cases which are pending between the parties before the Courts at Bangalore.

4. The said statement is not disputed by learned counsel for the respondent.

5. Having heard learned counsel for the petitioner and learned counsel for the respondent and on perusal of the material on record, we find that the petitioner has made out a case for transfer of the aforesaid petition.

6. In the result, the Transfer Petition is allowed and the petition viz., HMA/166/2021 titled, "Abhishek Ghai v. Jyoti Ghai" pending before the Civil Judge (Senior Division) at Chandigarh is transferred to the Court of Principal Senior Civil Judge, Bangalore Rural District.

7. The respondent is at liberty to appear either in-person or through video conferencing facility.

8. It is needless to observe that if the respondent seeks to appear virtually, then the competent Court shall make available the said facility to the said respondent.

9. Registry to communicate this order to the transferor as well as the transferee courts for taking steps in accordance with this order.
