2. Permission to file the special leave petitions is granted.
3. In this bunch of petition, the order of the High Court allowing the intra-court appeal preferred by the respondents is under challenge. The Division Bench of the High Court, upon appraisal of the materials placed on record, took the view that

the writ petitioners had challenged a communication letter based on a Tariff Order dated 20.06.2013. As there was no challenge to the Tariff Order, the appeals were allowed, the order(s) passed by the learned Single Judge was set aside and writ petition(s) dismissed.

4. After some arguments, learned counsel for the petitioners pray to withdraw these petitions with liberty to challenge the Tariff Order before the appropriate forum by filing appeal(s).

5. In such circumstances, we deem it appropriate to dismiss these petitions as withdrawn with liberty as prayed for. All contentions including one regarding maintainability of the appeal(s) are kept open to be raised before the appropriate forum.
